Sub: Scholarship Only for Minority Students 2016-17

This is for information for all the students that the Post Matric Scholarship for the year 2016-17 has been announced by the government for **MINORITY (Muslim, Christian, Sikh, Buddhist, Jain and Zoroastrians (Parsis))** students **only**. Students can submit their form through online mode on the website i.e. www.scholarships.gov.in

❖ The eligibility conditions are as under:

- 1) Scholarship will be awarded to the students who have **secured not less than 50% marks or equivalent grade in the previous final examination** and the **annual income of whose parents/guardian from all sources does not exceed Rs.2.00 lakh**. There are a fixed number of scholarships for minorities. Students from BPL families, having the lowest income shall be given preference in the ascending order.
- 2) The award will be discontinued if a student fails to secure 50% marks or equivalent grade in the previous final examination.
- 3) Scholarships will not be given to more than two students in a family.
- 4) The students should be regular in attendance for which the yardstick will be decided by the competent authority of the school/college/university.
- 5) Migration of students from one Institution to another would not normally be allowed during the course of the academic year except under exceptional circumstances and in the interest of the student's academic career.
- 6) Course fee/ tuition fee and maintenance allowance will be credited directly to the students' bank account.

❖ Procedure For Applying

- 1) The scheme is implemented through National Scholarship Portal (NSP). It is mandatory for all students to apply online on the website of this Ministry i.e. www.scholarships.gov.in.
- 2) The list of documents to be scanned & uploaded for both Fresh and Renewal Scholarships as under:
 - Student Photo
 - Institution Verification Form
 - Self declaration of Income Certificate by the student.
 - Self declaration of community by the student.
 - In case of Fresh: Self Attested Certificate of 'Previous Academic Mark sheet' as filled in Form.
 - In case of Renewal: Self-Attested Certificate of Previous Year Marksheet as filled in the Form.
 - Fee Receipt of current course year.
 - Proof of Bank Account in the name of student
 - Aadhaar Card
 - Residential Certificate

❖ It is mandatory for each student who is eligible for scholarship to submit the following documents in the administration department at the institute at the earliest:

- 1) Proof that the Adhar Card is linked with the bank account of the student.
- 2) Hard copy of the application form, filled online by the student.
- 3) Self attested photocopy of Caste Certificate.
- 4) Self attested proof of latest qualification.
- 5) Income Certificate
- 6) Pay slip

The last date for submission of application form through online mode is **31st October, 2016**. No form will be accepted either through online mode or in hard copy in any case, after the last date as mentioned above, by the institute.
